We decided to move over here. As it happens, he's eligible for SS benefits. But we weren't married in Australia. We got married in the U.S. The American version of social security, unlike ours, doesn't accept papers from other countries. So basically, he got nothing from the U.S. Social

Security system. Nothing. Zero. Nada. This was my first thought, that the U.S. won't allow dual citizenship. However, in talking to my husband's lawyer, it turns out that if the person who adopted him had been his mother or father, they would have been eligible for SS. My husband will be eligible for SS. It will be very low, but it will be something.
